

Pursuant to Article 46, paragraph 1, item 4) and with reference to Article 37, paragraph 1 of the Energy Law ("Official Gazette of RS", No. 57/11, 80/11 – corr. and 93/12),

On its 204th session of December 28, 2012, the Council of the Energy Agency of the Republic of Serbia adopted the following

DECISION

on Amendments to the Criteria and Standards for Setting Energy Licence Fees

1. In the Criteria and Standards for Setting Energy Licence Fees ("Official Gazette of RS", No. 76/11), section **I. Type and Scope of Regulatory Activities of the Agency**, item 5, paragraph 3 shall be amended and read as follows:

"The fee shall be determined according to this criterion for the following licenced activities:

- 1) by applying coefficient 2.5
 - electricity generation with a total installed capacity of over 1MW, combined electricity and heat generation in CHP plants with an installed capacity of over 1MW, electricity transmission and transmission system operation, electricity market organisation, electricity distribution and distribution system operation;
 - oil pipeline transport, oil derivative pipeline transport;
 - natural gas transmission, and transmission system operation, natural gas storage and storage operation, natural gas distribution and distribution system operation;
- 2) by applying coefficient 2.00
 - electricity public supply;
 - natural gas public supply;
- 3) by applying coefficient 1.00
 - electricity supply;
 - oil derivatives production, oil, oil derivatives and biofuels storage, trade in oil, oil derivatives, biofuels and compressed natural gas, trade in motor fuels and other fuels on petrol stations;
 - natural gas supply;
 - biofuels production of over 1000t."

2. In section **III. Technical characteristics of energy facilities, i.e. capacities or specific conditions for carrying out some of the licensed activities**, item 7, paragraph 3 including the table shall be amended and read as follows:

"The fee shall be determined according to this criterion for the following licenced activities:
